

MESSAGE FROM THE

board chair & ceo

March 2014 marked CCVO's 10th anniversary. Reflecting on the accomplishments of the past year is a powerful reminder of how far we have come on this journey of exploring the possibilities for a nonprofit "chamber" in Calgary.

It has been incredibly rewarding to see key parts of our work become essential parts of the sector landscape. The biweekly e-bulletin, the annual Alberta Nonprofit Survey, our Connections Conference, the Reach Hire job centre and the Innovation Awards all contribute to a stronger sector through access to better information, supportive services and fostering

connections beyond the boundaries of our individual organizations.

Last year's floods were a defining event in our community and many organizations and individuals are still dealing with the aftermath. CCVO's immediate response, to coordinate collecting information about the impact on nonprofit organizations, led to a series of surveys and reports that informed decision-makers and raised awareness of the need for greater preparedness to meet the challenges of future emergencies. The experience of the past year has reinforced the importance of being nimble to adapt to rapid change and unforeseen circumstances, but also the value of having a clear sense of purpose and direction.

We look forward to developing a new vision for CCVO that extends beyond our strategic plan and will provide a framework to guide us over the next 10 years.

Thank you to all of our members, associates, funders, volunteers, partners and sponsors; your support makes our work possible. And a special thanks to our Board of Directors and outstanding staff team, for setting high expectations and always exceeding them.

promoting the sector


CCVO promotes the role of the nonprofit sector, building awareness about issues experienced by charities and nonprofits, and ensuring the sector's perspective is heard in relevant policy discussions.

We also represent the sector through our submissions, consultations and participation in government and other committees or working groups, such as Alberta Nonprofit/Voluntary Sector Initiative (ANVSI), the Human Services Workforce Alliance and others.

Two examples of our participation include:

 Actively working towards the renewal of ANVSI, to provide a space for government and the sector to work together to understand and resolve issues. international regulatory experts, and other sector leaders in meetings to discuss the laws by which nonprofit organizations can become incorporated in the Province of Alberta.

On April 14 and 15, 2014, more than 350 passionate and highly engaged participants from nonprofits, corporations and governments met at the third annual Connections Conference under the banner of "One Great Idea, One New Connection, One Bold Action." Our amazing speakers the Right Honourable Joe Clark with Bob Wyatt, Amanda Lang, Jocelyne Daw and Ashley Good, each in their own way wove together a common theme of the need to innovate and the courage to risk failure in order to succeed, both in our work and our everyday lives.

Our workshop presenters rounded out the program with inspiring case studies and practical takeaways that left our delegates wanting more.

FLOOD RESPONSE

telling the story

Within the first few days of the June floods, CCVO immediately set to work to gather information on the initial impact of the disaster on Calgary's nonprofit sector.


Reaching hundreds of organizations though our network, we worked to determine the extent of flood damage, and captured information on

immediate and longer-term financial needs, service demands, and concerns over donor fatigue.

Our comprehensive series of research reports was used by government and funders to inform the direction of relief funding, helped enhance capacity building initiatives, and was cited extensively by the media to help tell the

story of the impact of the floods on the nonprofit sector.

CCVO continues to work to encourage emergency preparedness in the sector and to find ways to integrate services in the event of the need for another city-wide response.



"On Sept. 12, the Calgary Chamber of Voluntary Organizations released a survey stating that many non-profits are concerned about lost revenue due to the flood, particularly from individual and corporate donations. For example, funds raised at this year's Easter Seals Drop Zone were down 45 per cent compared to last year."

In surveying more than 300 non-profits, the report found nearly 20 per cent suffered damage in last spring's floods and many are still struggling with repairs, compensation and stretched staff."

Each of the award winners illustrates examples of unique collaborative partnerships, gamechanging ways of


operating, and inventive service offerings.



Jilll Wyatt United Way of Calgary and Area This year's Alberta Nonprofit Survey is the seventh in our series, and continues to build a strong foundation of information about the Province's nonprofit and charitable sector.

This snapshot of the health and experience of Alberta's nonprofits and charities captures details on finances, demand for services, staffing and the future economic outlook of organizations. It also looks at timely and topical issues such as the implementation of the Social Policy Framework, the effects of the elimination of STEP and Community Spirit programs, and the impact of the 2013 floods.

This report is the only source of Alberta-specific information, and is used extensively by individual organizations, boards of directors, government agencies and funding bodies to better understand the changes and trends occurring across the sector in the past year.




Across the province, labour market pressures and an aging workforce have created an environment where nonprofit organizations must prepare themselves for transitions in executive leadership in order to continue their vital role. Turning Point is the result of CCVO's multi-stage research project on current issues of leadership.

Drawing input from hundreds of current and emerging leaders, the report speaks to the aspirations and challenges that stem from an inevitable transition in leadership across the sector, and summarizes the most critical steps that must be taken to ensure effectiveness, resiliency and sustainability, to create quality service for all Albertans.

Aboriginal peoples, mature workers, immigrants, and people with disabilities all experience rewarding careers in our sector but they are often in the minority among our employees.

Now more than ever, Alberta's nonprofit organizations must take intentional steps to attract, develop and retain employees from these currently underrepresented groups.

An initiative of the Alberta Nonprofit Workforce Council, and led by CCVO, In the Mix promotes diversity through the stories of four diverse Calgarians working in the nonprofit sector.

promoting capacity


Through capacity building and skills development workshops, peer to peer discussions, and information and dialogue sessions, CCVO engages hundreds of nonprofit






